# Parkable - linking drivers to property owners' empty spaces

A new app being piloted in Kingsland was well used during the Bledisloe Cup and 100 more parking spaces are now available near the village. If you have spare business parks (during business or after hours), a driveway, lawn or any other parking space you can turn it to cash, or donate to charity.

#### 10. QUESTIONS & DISCUSSION

Warwick Beauchamp outlined how the Parkable app works to seamlessly connect drivers looking for parking with hosts who have parking space available. He discussed that available parking spaces were 170 and counting in and near Kingsland village. The big issue is to get the word out to drivers to encourage them to use the app. Asked about two other entrants with similar apps, Warwick advised neither business was up nor running as yet and one had already approached Parkable to buy it.
